L. Public Comment/Other:

- Councilman Smiley stated that City Council President Shabazz informed him that City Council is adding signage to the council chamber doors to remind members of the public not to enter council’s floor while council is in session.
- Councilman Smiley noted that April 25th is Professional Employees Day and thanked council staff for the work that they do every day.
- Councilman Bell commented on the appointment of William McDuffy to the New Castle County Diversity Commission.
- President Hartley-Nagle noted that she also spoke with City Council President Shabazz and noted that City Council has not had an issue, but rather City Council was being pro-active by adding the additional signs.

- Councilwoman Kilpatrick asked for clarification on the process of introducing legislation.
- Councilman Hollins noted that a vote to withdrawal legislation is not necessary.

- Scott Sauer spoke about the outstanding debt facing New Castle County, abandoned properties and the budget.
