Title: MASTER CARPENTER

Approved:

GENERAL STATEMENT OF DUTIES: Performs skilled and detailed carpentry work at the full-performance level; does related work as required.

<u>DISTINGUISHING FEATURES OF THE CLASS</u>: An employee in this class constructs, erects, installs, and repairs structures and fixtures of wood, wallboard, plywood, laminating materials, and similar materials. This employee uses a wide variety of hand tools and power tools in the course of the work. Projects include construction and repair of desktops, countertops, cabinetry, tables, shelving, storage units, doors, windows, building renovations, framing, trim, molding, forms for pouring concrete, ceilings, and roofing. Responsibilities include designing and laying out projects, locating materials, and making cost estimates. This employee works under general supervision and supervision may be exercised over skilled and unskilled workers.

## EXAMPLES OF WORK: (Illustrative Only)

- Inspects jobs to determine scope of job, appropriate repair, or construction methods and materials and equipment needed;
- Designs, lays out, and constructs cabinets, tables, shelving units, bookcases, storage units, and other office furniture;
- Constructs, installs, and repairs window frames and windows;
- Installs and repairs doors and related hardware, such as dead bolt locks, keying systems, panic devices, and door closures;
- Erects wood and metal framework;
- Installs drywall;
- Measures, cuts, shapes, planes, and installs trim and molding;
- Designs and makes picture frames;
- Repairs desktops, countertops, and other laminated surfaces;
- Designs and makes renovations to offices and work areas;
- installs drop ceilings;
- Estimates time and materials needed, locates materials, and figures approximate cost of projects;
- Installs and repairs roofing;
- Constructs forms for pouring concrete;
- Reviews and works from plans, specifications, and blueprints as needed;
- Requisitions materials, tools, and equipment;
- Does minor painting, masonry, and related building trades work;
